I have the pleasure to send you the following information related with the organisation of the **FINA SCHOOL FOR DIVING JUDGES** in Europe.

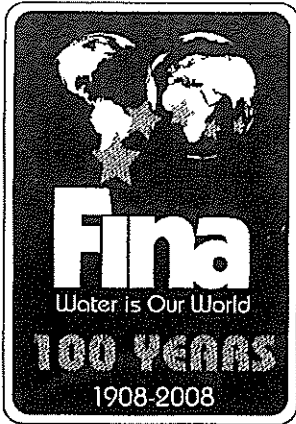
The purpose of this course is to achieve the following objectives:

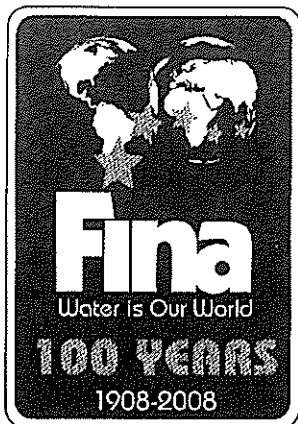

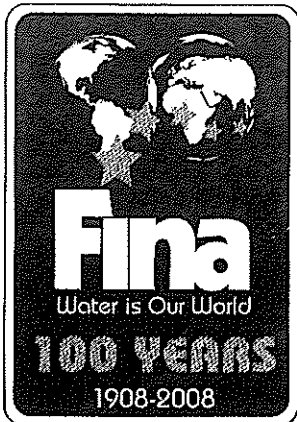
